

AEON Specialized Bank “Pump to get monthly Cashback at Gasoline Stations” Terms and Conditions

Definition

1. The “**Campaign**” means “Pump to get monthly cashback at Gasoline Stations” organized by AEON SPECIALIZED BANK (CAMBODIA) PLC. in accordance with the Terms and Conditions as herein stipulated.
2. **AEON SPB** refer to “**AEON Specialized Bank (Cambodia) PLC.**”
3. **TOTAL** refer to “**TOTAL CAMBODGE Service Station.**”
4. **CALTEX** refer to “**CHEVRON Company.**”

Campaign Duration

5. The Campaign is from **08th March to 31st August 2021** (“**Campaign Duration**”) at **TOTAL** or such other Duration(s) as may be determined at the sole and absolute discretion of **AEON SPB** without prior notice.
6. The Campaign is from **01st April to 31st August 2021** (“**Campaign Duration**”) at **CALTEX** or such other Duration(s) as may be determined at the sole and absolute discretion of **AEON SPB** without prior notice.
7. Eligible cardholder’s transaction shall be made every day during Campaign Duration.

Eligibility

“**Eligible Cardholders**” means customers of **AEON SPB** having a AEON Credit Card during the Campaign Duration as herein described but do not include Cardholders whose Card accounts have been suspended, cancelled or terminated for whatsoever reasons during the Campaign Duration.

Eligible Transaction

8. The Eligible Transactions shall receive cashback on its respective transaction amount based on transaction time stamp as recorded in **AEON SPB**’s system date and time (“**up to USD3 Cashback**”).
9. The Eligible Transactions mean transactions for purchase of goods and services incurred for personal consumption, and **not for business purposes, excluding Eligible Transactions which are subsequently cancelled, disputed, refunded, unauthorized or fraudulent transactions.**
10. Subject to the Terms and Conditions hereinafter appearing, all Participants are required to use AEON Card to perform transaction at all participated **CALTEX stations** and **TOTAL** stations accepted AEON Card Payment following stations business hours.
11. Eligible transaction for cashback shall be based on Merchant name, **TOTAL** and/or **CALTEX**.
12. Participant transaction shall be accumulated on monthly basis meaning that every day of each month “**Monthly Accumulated Purchase**”.
13. Monthly Accumulated Purchase shall follow the Cashback offers as below:

Remark: Principal Cardholder is only entitled to a maximum cashback of **USD 3 (Three US Dollar Only)** per month.

All spending either by Principal Card or Supplementary Card shall be accumulated and the Cashback shall be transferred to Principal Card only.

14. Notwithstanding the foregoing, **AEON SPB** reserves the right to use any other medium or method, including **AEON SPB**’s website at www.aeon.com.kh as it deems fit in its sole and absolute discretion for the purpose of announcing the Participants entitled for USD 3 (up to) Cashback.
15. The Cashback shall be credited into the Eligible Cardholder account, **within 10 days of the next following month.**

16. Any determination by **AEON SPB** as to what constitutes Eligible Transactions is conclusive and cannot be challenged in any manner whatsoever. All transactions as recorded by **AEON SPB** shall also be final and conclusive.
17. Participation **TOTAL** Station Outlets (**Accepted AEON Card Payment**).
18. Participation **CALTEX** Station Outlets (**Accepted AEON Card Payment**).

Disqualification

19. **AEON SPB** reserves the absolute right to **disqualify the participation of any Eligible Cardholders** for the purpose of this Campaign without having to alert him/her in the event:
 - (a) the Eligible Cardholder's Card account is in default during the Campaign Duration; or
 - (b) the Eligible Cardholder's Card account is closed during the Campaign Duration; or
 - (c) the Eligible Cardholder has provided untrue information or acted fraudulently in any manner during the Campaign Duration; or
 - (d) the Eligible Cardholder breaches any of these Terms and Conditions stipulated herein.

Liability

20. **AEON SPB** shall not be liable to any Participant for any damage of whatsoever nature or loss suffered (including but not limited to, loss of goodwill, income or profits or consequential, direct or indirect, exemplary, incidental, punitive or special damages) howsoever arising in relation to participation in the Campaign, or **AEON SPB** exercising its rights pursuant to any of the Terms and Conditions herein.

General

21. **AEON SPB's** decision on all matters relating to the Campaign is binding and final and no further correspondence or appeal shall be entertained. All Terms and Conditions stipulated herein are governed by and construed in accordance to the laws of Cambodia and any legal disputes shall be commenced and heard in courts in Phnom Penh.
22. All Participants have read and understood all the Terms and Conditions specified herein and **AEON SPB** shall have the absolute right to suspend, terminate or cancel the Campaign at any time without any reasons and without prior notice as stated on **AEON SPB** website at www.aeon.com.kh.
