

**“Shop to Get more than USD 7.00 Cashback with APP or APPROVAL  
CODE number “xxxx77” with AEON Card”.**

**Terms and Conditions**

**Definition**

1. The “**Campaign**” means “**Shop to Get more than USD 7.00 cashback with the last 2 digits of APP or APPROVAL CODE number “xxxx77”.**”
2. **AEON Card** refers to activate of AEON Gold Card and AEON Violet Card with both Principal and Supplementary whose such AEON Card Accounts have not been suspended, cancelled or terminated for whatsoever reasons during the Campaign period.
