

AEON SPECIALIZED BANK (CAMBODIA) PLC.
“Pump to get monthly cashback at gasoline stations with AEON Card.”
Terms and Conditions

Definitions:

- The “**Promotion**” refers to “Pump to get monthly cashback at Gasoline Stations with AEON Card” organized by **AEON SPB** in accordance with the Terms and Conditions as herein stipulated.
- **AEON SPB** refers to “**AEON Specialized Bank (Cambodia) PLC.**”
- **Gasoline stations** refers to cooperate stations such as “**TotalEnergies and Caltex Cambodia Stations**” both in provincial and Phnom Penh that accepts AEON Card payment.
- **Eligible Cardholders** refers to customers of **AEON SPB** (Including AEON SPB’s staffs) having AEON Card during the **Promotion Period** as herein described but do not include Cardholders whose Card accounts have been suspended, cancelled, or terminated for whatsoever reasons during the **Promotion Period**.

Promotion Period:

The **Promotion** is from **01st January 2025 to 31st December 2025**, both dates inclusive (“**Promotion Period**”) or such other Period(s) as may be determined at the sole and absolute discretion of **AEON SPB** without prior notice.

Eligible Transaction:

- Eligible Transactions shall receive cashback on its respective transaction amount based on the transaction timestamp as recorded in **AEON SPB’s** system date and time (“**up to USD 3 Cashback**”).
- The Eligible Transactions mean transactions for the purchase of goods and services incurred for personal consumption, and **not for business purposes, excluding Eligible Transactions which are subsequently cancelled, disputed, refunded, unauthorized or fraudulent transactions.**
- Subject to the Terms and Conditions hereinafter appearing, all Participants are required to use AEON Card to perform transactions at all participated Caltex station and TotalEnergies station accepted AEON Card Payment (Exclude AEON Card Mobile Scan to pay) following stations business hours.
- Participant transactions shall be accumulated on monthly basis meaning that every single day of each month during the campaign duration “**Monthly Accumulated Purchase**”.
- **Monthly Accumulated Purchase** shall follow the Cashback offers as below:

Remark:

- Principal Cardholder is only entitled to a maximum cashback of **USD 3 (Three US Dollar Only)** per month.
- All spending either by Principal Card or Supplementary Card shall be accumulated and the Cashback shall be transferred to Principal Card only.
- The Cashback shall be credited into the Eligible Cardholder account, **within 10 working days of the next following month.**
- Any determination by **AEON SPB** as to what constitutes Eligible Transactions is conclusive and cannot be challenged in any manner whatsoever. All transactions as recorded by **AEON SPB** shall also be final and conclusive.
- Participate Gasoline: **All TOTAL Energies and Caltex stations in Cambodia (which accepted AEON Card Payment).**

Disqualification:

AEON SPB reserves the absolute right to **disqualify the participation of any Eligible Cardholders** for the purpose of this Campaign without having to alert him/her in the event:

- (a) the **Eligible Cardholder's** Card account is in default (the detail of "Default "please click the link ([TCs-AEON-Card-ENG](#) & [TCs-AEON-Card-KH](#)) during the **Promotion Period**; or
- (b) the Eligible Cardholder's Card account is closed during the **Promotion Period**; or
- (c) the Eligible Cardholder has provided untrue information or acted fraudulently in any manner during the **Promotion Period**; or
- (d) the Eligible Cardholder breaches any of these Terms and Conditions stipulated herein.

Liability:

AEON SPB shall not be liable to any AEON Cardholders/Participants for any damage of whatsoever nature or loss suffered (including but not limited to, loss of goodwill, income, or profits or consequential, direct, or indirect, exemplary, incidental, punitive, or special damages) however arising in relation to participation in **the Promotion**, or **AEON SPB** exercising its rights pursuant to any of the Terms and Conditions herein.
